1. Student Health Service Provided by Department of Health

The Student Health Service is a health promotion and disease prevention programme provided for all Hong Kong students by the Department of Health. For details, please refer to the relevant notice distributed by the class teachers. No matter if your child is going to sign up for the programme or not, s/he needs to fill in the form and submit it to the class teacher by 9th September (Mon). Also, the department will provide hearing tests for all S.2 students in 2024-2025.

2. Invitation for eHealth Registration (Via School Enrollment)

Developed by the Government and rolled out in 2016, the Electronic Health Record Sharing System (eHealth) provides a territory-wide and secure electronic platform that allows authorised healthcare providers (e.g. hospitals, clinics) in the public and private sectors, with registrant's consent, to view and share Health participant's electronic health records (eHRs) within the sharable scope on a "need-to-know" and "patient-under-care" basis. The eHealth mobile application (the App) was launched in 2021 to enable users to view parts of their own eHRs, obtain useful health information and actively manage their own health, etc.

eHealth has gradually covered records of vaccinations under different Government Vaccination Schemes. Riding on the invitation to the 2023/24 Seasonal Influenza Vaccination Programme (the SIV Programme) by the Department of Health (DH), we would like to encourage parents and guardians as well as students aged 16 or above to register Health for their children or themselves free of charge and voluntarily, with a view to enjoying the benefits, including access to vaccination records via the App to save their time in managing paper vaccination records. This also enables the establishment of personal, lifelong and privacy-protected eHRs for continued healthcare services.

2.1 If S.1 students' parents are interested for your children to register eHealth through the school, please complete the reply slip and consent form on or before 9th September (Mon), and return them to the class teacher.

2.2 For parents of students in S.2 to S.6 who have not yet registered their children for the eHealth system last year but are still interested in participating, please complete the reply slip by 9th September (Mon). The school will distribute the registration forms later to complete the registration process.
